Mrs Caddy's field is a 19 acre greenbelt floodplain site managed by Runnymede Borough Council. Specific Risks that everyone (volunteers, exhibitors and contractors) coming onto the showground should be aware of:


The nature of the field is rough and uneven grassland.

Extreme weather conditions particularly heavy rain fall, could affect the condition of the showground, due to being a floodplain the ground may become very soft and muddy, which will mean heavy vehicles may not be able to access the showground.

When arranging contractors to erect temporary structures such as marquees and deliver equipment to site these risks must be identified to them, so that they are aware of showground conditions and can make appropriate arrangements so as to minimise any potential incidents occurring.



SHOWGROUND GENERAL DESCRIPTION

The Egham Royal Show is a two day open air Agricultural show, Horticulture marquee and Music Festival with Family Attractions and Children's activities. The showground will be set up the week before and taken down the week following the show dates.

The show is situated in an open green belt field which has rough ground. An exterior Heras security fence is erected with vehicle and pedestrian entrances. There are marked emergency exits and allocated emergency pathways as required.

The show has an expected attendance of 5,000 visitors over the course of two 8-hour days with an estimated peak attendance of 3,000 at any one time. Visitors are expected to be mainly adults and family groups.

The Show comprises:

Livestock at the show comprise of cattle, pigs and sheep. All livestock are held within secure pens under a marquee and showing rings. They also adhere to DEFRA regulations.

Fairground attractions, Family amusement show, Archery and Simulator ride.

The dog show comprises an open air ring with a program of dog competitions.

The main arena is used for a parade of the livestock section of the show and to display the programme of arena events as timetabled.

The main attractions are Motorbike Stunt teams as well as Scurry Driving and Falconry display, they are each responsible for adhering to the appropriate regulations, and will be allocated a secure area for when they are not in the main ring.

Display of models including miniature steam trains, fairground exhibits and working organ within a marquee, and a pond for exhibitors to demonstrate their model boats and yachts on.


Display area for Vintage & Classic Cars, Motorcycles and Historic Commercial vehicles, with parade slots within the main arena programme.

Horticulture marquee with a competitive display of produce and flowers that have been grown, Handcrafted items, Paintings, Drawings and Homemade Baked items. As well as a competitive display of Floral Arrangements.

Music festival with a stage for local musicians and singers to showcase their talent throughout both Show days.

Trade Shopping within Open trade spaces and Public Catering units.

Community marquee serving lunch for members of the association and invited guests.





SHOWGROUND MANAGEMENT FOR THE EGHAM ROYAL SHOW

Site preparation, Build up and Break down:

In the event of any major incident the association holds employees liability insurance, and ensures that all contractors coming onto the showground adhere to appropriate guidance and regulations in place and hold their own appropriate insurance.

Site Preparation:

The grass will be mowed by competent persons using their own personal mowing equipment.

Site Access and Security:

The Showground Manager will hold a record of contractors that have been arranged along with when they will be on site and for what purpose to minimise the risk of unauthorised entry to the showground.

There will be a security log book to sign in and out when accessing the ground so that should an incident occur all persons can be contacted by mobile phone to vacate the ground as required.

Entry and Exit will be via the vehicle entrance gate, the Gate is kept shut and locked when there are no key officials within close proximity to the Gate. During this time anyone requiring access can contact the Key Holder by Mobile.

Vehicle Movement:

Vehicles moving around on site should stay below 15 MPH, and use hazard indicators or orange beacons if fitted. The driver should remain vigilant at all times, particularly during the erection of the Haris fencing.

First Aid:

There should be an appointed person with at least basic First Aid knowledge present on site at all times. In the event that someone is injured the nominated first aider should assess and treat the injury. Depending on the severity will depend on if the injury can be dealt with from the available basic first aid kit or an ambulance needs to be called from a mobile phone to take the casualty to hospital.

In the event of a work related serious injury that requires hospital treatment or death this must be reported to RIDDOR within 7 days.

Infection control:

To minimise the spread of infectious disease Hand sanitising or Hand wash washing facilities will be located near the main gate so that volunteers and contractors accessing the ground can clean hands on arrival at the site, and before and after having food and drink.

Risk of Fire:


As the showground is grass, be aware of high heat in summer drying out the grass and increasing the risk of fire. Maintain appropriate distance between vehicles, and ensure engine's are turned off when not being used. Setup tap water supply on site, and have buckets filled with water in the event of a fire.

There should be a Foam or CO2 fire extinguisher available on site in case of vehicles and machinery fires.

Movement of machinery and Public safety:

Due to the field being open public ground, while the Heras fencing is being erected/removed around the area to be used for the showground signs should be displayed at the main points of access to the field (by gates and public walkways) to warn members of the public to be cautious as machinery (telehandlers in particular) is in operation so they can take adequate precautions to keep children and animals under control and safe.

The signs can be removed, except the one by the vehicle access Gate, once the heras fencing is erected, machinery will be used to bring equipment onto the showground and moved to the area where required within the heras fencing area.





Machinery used such as telehandlers, should be driven by or under instruction from an experienced competent person, the risk of use should be assessed to limit any potential incidents, particularly due to the nature of the ground conditions being uneven and potentially soft increasing the risk of tipping over particularly when lifting and moving heavy/awkward loads, be vigilant and cautious due to restricted visibility when manoeuvring to minimise risk and prevent injuring someone.

Showground Build and Break down:

Erection of fencing, care should be taken to avoid incidents that can cause injury. All panels should be well secured to prevent movement except where indicated for use as Gates.

Appropriate protective clothing (such as heavy shoes/boots & gloves) and precautions should be taken when handing, fencing panels, hurdles, metal stakes and wooden posts to knock into the ground firmly.

Toilet facilities:

There should be a portable toilet on site near the main entrance.

Contractors:


The Show Manager will record Contractors entering and exiting the showground to ensure they are authorised and expected, and direct them as required.

Contractors should have their own liability and employee insurance to carry out work being undertaken, comply with all legal requirements, fire procedures and safety regulations.

Contractors should carry out their own risk assessment based on the advised ground conditions to ensure that correct precautions can be undertaken, such as bringing heavy vehicles that could sink into the soft ground.

There are marquees which are erected by a contracted professional external company, all guy lines are blue and positioned so that they do not cause a trip hazard when entering and exiting marquees. Hazard tape must be tied around the securing pegs to minimise the risk of tripping over them.

Trade stand pitch sizes are allocated so that there is sufficient spacing to allow for a Gazebo to be erected and not encroach on neighbouring pitches. It is the Traders responsibility to ensure that guy lines do not prevent a hazard to members of the public that visit their trade stand and traders must hold their own liability insurance.





Show Weekend:

In the event of any major incident the association holds public liability insurance, and ensures that all traders, exhibitors and competitors coming onto the showground adhere to appropriate guidance and regulations in place

Vintage, Classic & Historic vehicles should hold appropriate insurance to cover their vehicles.

Livestock, particularly cattle are required to hold appropriate insurance in the event that an animal gets out of control.

All Traders, Public caterers, demonstrators and attractions should hold suitable public liability insurance and complete individual risk assessment for their trade. Traders using electronic equipment being plugged into generators must ensure it has an up to date PAT sticker.

Site Access and Security:

Access will be permitted onto the Showground via the Vehicle Gate for setting up on Friday 26th and outside of the official opening & closing times on Saturday 27th & Sunday 28th for those displaying a valid vehicle pass and exhibitor pass. No Vehicles will be allowed to move on the showground during the official opening & closing times, except in the case of an emergency or as directed.

Entry for the General Public will be on foot between the official opening & closing times on both show days via the appointed pedestrian gates.

There will be a copy of this document available and a security log book to sign in and out when accessing the ground outside of daytime hours (7pm until 7am) so that there is a record of movements should an incident occur overnight.

Vehicle Movement:

Vehicle movement on the showground on show days is only permitted before and after the official opening & closing times of the show, vehicle's need to drive at 10 MPH or slower and have hazard indicators on, drivers to remain vigilant at all times.

First Aid:

There will be a professional organisation contracted to provide adequate cover for the duration of the show days. In the event of a serious injury that is life changing such as a bang to the head or death this must be reported to RIDDOR within 7 days.

Infection control:


To minimise the spread of infectious disease Hand sanitising or Hand washing facilities will be located around the showground i.e. main toilets and near the livestock areas for people to wash hands regularly particularly when using the toilet, before and after eating, drinking and touching livestock.

Toilet Facilities:

There are toilets with disabled access as well as toilet units which are hooked up to generators and water with facilities for both males and females. Baby Change facilities are also available.

Lost Children:

In the event that a child becomes separated from its parents, the child should be bought to the Show Office, where at least 2 show officials can look after them, at least one official holds a valid DBS certificate through the Updater service. An announcement should be made over the main PA system asking for the lost parents to come to the Show Office.





In the event that a parent becomes separated from a child, and the location of the child is unknown, a radio request to prevent any children leaving the showground should be given to the gates until the child is located, and announcements made over the PA systems asking the child to make themselves known to a Show Steward so they can be bought to the Show Office.

Showground Communication:

Communication between show officials will be through two-way radio and mobile phone.

Instructions for using the Radio, for example saying Over at the end of communication/message, and pressing and holding the button only when talking along with the channels allocated for use will be given on allocation of the radio. There is a list of emergency mobile numbers in the Show Office and will be given to Show officials & Stewards.

Communication to the public will be through the public address systems on the showground. Verbal instructions will be used within the marquees and areas not covered by the Public address systems.

Weather Condition Precautions:

As the show is held on an open field, extreme weather conditions need to be taken into consideration.

During long periods of high heat the grass dries out, increasing the risk of Fire. Extra precautions should be taken regarding fire hazards such as disposing of Smokers materials and glass properly. As well as having extra buckets of water placed around the site near bins, marquees and livestock areas.

When there are long periods of heavy rainfall the ground may become very soft and muddy, so extra care and precautions need to be considered for both pedestrians and vehicles entering and exiting the Showground and Car Parks, and appropriate footwear should be worn.


High winds and Storms can pose a risk to marquees and any other vulnerable structures, guy lines and securing pegs should be constantly monitored and checked to ensure they are secure during/following a storm. With winds reaching 25 to 30 mph the marquee doors should be kept closed, and have someone allowing people in and out of one or two doors only. When winds reach around 35 mph upwards the marquees should be evacuated and all doors secured, it may also be necessary to have the contractors on standby to take down the marquee if the need arises for safety.

Gazebos are not recommended to be erected with winds in excess of 20 mph, any gazebos erected should be taken down when winds start reaching 20mph.

Precautions should be taken during lightning storms due to risk of Fire if lightening hits a marquee or high structure.

Stockmen should take necessary precautions for livestock to avoid them getting loose or injured during high winds and storms.

Dog owners should ensure dogs are kept secure and under control at all times. Dogs should never be left unattended in vehicles. Water should be available for dogs to drink, especially in high heat.





HEALTH AND SAFETY COMPLIANCE

Egham & Thorpe Royal Agricultural & Horticultural Association are required to comply with current Health and Safety regulations, therefore all persons using the Showground be they Trade Stands, Live Stock Exhibitors, Craftworkers, Caterers, Contractors (including their servants, employees or agents) or Committee members, Association members and Volunteers must comply with the provisions of the current Health and Safety at Work Act, and subsequent Regulations, at all times.

Electrical Equipment and Generators

All electrical equipment must have been inspected and tested by a competent electrician within the last 24 months, and a certified PAT label affixed to it giving the date of the test and the name of the person who carried out the test. All electrical equipment should be installed and used in accordance with HSE Guidance Note PM32 "Safe use of portable electrical apparatus" and be connected to the supply through a RCD of 30mA sensitivity.

Generators must be declared when booking to attend the show, otherwise usage of them will not be permitted. Fuel should be kept away from the Generator and other ignition sources, Generators should be turned off & cooled before refueling, never while hot or running.

Appropriate Fire extinguishers should be available nearby so that in the event of fire it can be distinguished quickly.

Gas Appliances

All gas appliances must have been examined and tested by a competent person and labelled to indicate the examiner's name and date of inspection. The use of untested appliances on the Showground will not be permitted.

The storage, use and transport of Calor and LPG cylinders on the Showground must be in accordance with HSE Guidance Notes. Appropriate Fire extinguishers should be available nearby so that in the event of fire it can be distinguished quickly.

Vehicles and Appliances

All steam, pressure vehicles or lifting appliances must have undergone a recent inspection by a competent person and be labelled to indicate the date of inspection and the name of the person who inspected it. Steam boilers must hold a current boiler certificate and appropriate insurance.

The Show manager must be notified not later than two weeks before the Show of all machinery that will be in motion on your stand or other live mechanical or electrical demonstrations.

All equipment must be totally guarded with adequate warning signs, and demonstrations must be supervised by a competent person at all times.

Tractors, motor vehicles and other self-propelled implements must be immobilised when not in use. Machinery, plant and equipment must be adequately supported to prevent moving or tipping over, sharp edges must be protected and moving parts guarded. Hydraulic rams must be suitably propped with steel props if demonstrated in an extended position.

Smoking

Smoking is not permitted in any marquee, in close proximity to straw, other combustible material or fuel supplies.

Marquees

Any marquee erected should comply with current Fire Regulations, tent pegs well driven into the ground or identified to prevent tripping and injury - especially near entrances/exits. No post holes are to be bored or any other digging or excavation to take place. Appropriate Fire extinguishers should be available so that in the event of fire it can be distinguished quickly.

Flag Poles and Signs

Flag poles and high signs must be adequately fixed to withstand wind and other stresses, and removed in the event of high winds reaching over 20mph. Stays should be identified with streamers as and where necessary.

Fairground Rides

The "Code of Safe Practice at Fairs" must be observed where any fairground device or passenger carrying ride is operated, and the operators should hold appropriate insurance.

Infection control:

To minimise the spread of infectious disease there will be Hand sanitiser or Hand wash stations located in key areas with appropriate signage to encourage people to regularly wash their hands, particularly after touching livestock and before eating & drinking. Also current Government guidelines will be adhered to.





MAIN HAZARDS: GENERAL

Marquees: Guy Ropes to be positioned away from doorways, Tent Pegs to have Hazard tape

around them, Tables to be placed as firmly as possible, Gangways to be kept

clear.

Vehicles on Showground: Must Arrive and be parked up before the official show start time, Departure will

be allowed after the official show close time.

Minimised movement between official show start and show close will be for emergency vehicles ONLY, and those moving between the Display zone and Main

Arena at the designated time slot.

Rubbish: Provide adequate rubbish bins around showground, and ensure ALL are emptied

between show days.

Infectious Diseases Prevent the transmission of infectious diseases as far as is possible, by providing

adequate hand sanitiser or hand wash facilities and signage. As well as following

appropriate government guidelines.

Livestock: Adhere to DEFRA regulations for Welfare of animals and humans, where

appropriate take veterinary advice. Provide hand washing facilities for the public

when touching animals.

Show Rings: Ensure all stakes are firm and secure and rope is securely attached.

MAIN HAZARDS: FIRE/ EXPLOSION

Smoking: Fire Hazard, No smoking throughout ALL Marquees, around Livestock, Display

rings, Attractions, Demonstrations and Trade Stands.

Sources of Ignition: Cooking equipment, discarded cigarettes, faulty or misused electrical equipment,

naked flames.

Sources of Fuel: Flammable liquids & gasses, displays / stands, furniture and fittings, livestock

feed and bedding, waste material, dry grass.

Sources of Oxygen: Natural air flow, through temporary structures.



EMERGENCY PROCEDURES FOR ALL SECTIONS

The Association has emergency procedures in place, follow the required action to be taken in the event of an accident, fire, explosion or foot & mouth or other infection incident.

All show volunteers should familiarise themselves with the following procedures.

In the event of an emergency the following procedure applies:

- ENSURE YOUR OWN SAFETY AT ALL TIMES
- summon assistance
- inform the Main Show Manager / Fire Manager
- where possible act immediately to halt the source of the emergency if you are qualified to do so. If not please stay calm and wait for assistance.

FIRE SAFETY

On discovering a fire, raise the alarm by shouting 'FIRE'. Use the nearest radio in your area to contact the Main Show Manager so that emergency services can be informed.

Only attempt to extinguish a fire where there is no risk of personal injury either from the fire, toxic gases and fumes produced or structural failure of the marquee. Ensure you always have a clear escape route at all times.

When attempting to extinguish a fire ensure you use the appropriate type of fire extinguisher. Fire extinguishers may be colour coded or have red bodies with coloured labels on them .
